competitive era. He emphasized on the scope of E- Commerce in expanding the businesses with leaps and bounds. He showed the comparative study of dependence on e- commerce by

India and China by presenting relevant facts and data. He explained that opting for online services we can get lots of options as compared to purchasing directly through shops. He also highlighted some of the attractive points which a person should know before opting a business online. Some of them are:

- → Attractive name of the website through which business is to be done. Perfect selection of Customer groups.
- **♣** Offering various discounts, schemes, prizes and coupons.
- ♣ Complete descriptions of Products at site including correct office address and contact numbers.
- **High definition pictures.**
- ♣ Providing facilities like after sale services, cash on delivery, exchange facilities and many more.

He discussed about the different types of E-Commerce as:

B2B [Business to Business]

B2C [Business to Customers]

C2C [Customer to Customer]

He concluded by making people aware that THE DECISION IS THERE'S .They have to decide whether they want a win-win situation or want to save their business from the grasp of online business mode.

The session was very interesting and lively. People were very curious and shared their personal experiences in their business life. Mr Mandot beautifully explained to them.

The second session was on GST- Goods and Service Tax and the renowned speaker of this session was CA Sanjay Dhariwal. Mrs. Mona Bafna introduced the gathering about the speaker. Thereafter the dias was handed over to Mr. Dhariwal.

Mr. Sanjay Dhariwal briefly introduced about the concept of Goods and Service Tax [GST].

Goods and Services Tax is a domestic trade tax that will be levied in the form of a value added tax on all goods and services- in practice with such exemption. The decision on which is pending for approval by the Central Government. It will replace all indirect taxes levied on goods and services by the Indian Central and State Governments. It is aimed at



being comprehensive for most goods and services.

He highlighted about the needs and merits of introducing the concept of GST in the tax structure. He explained about three types of GST namely State GST, Interstate GST AND Central GST. He also highlighted various exemptions available:

- 1. Public Services.
- 2. Unprocessed goods sold under the Public Distribution system.
- 3. Defense and police.
- 4. Employer-employee transactions.
- 5. Education services provided by Non-Governmental bodies.
- 6. Health Services provided by Non- governmental agencies.

This was followed by the brief speech given by the National TPF President Mr. Salil Lodha.

He narrated about the recent activities organized by Terapanth Professional Forum in different centre of the Country. He also discussed about the Future course of activities.

Mr. Lodha advised the members to undertake certain activities such as:

- ♣ To provide all sorts of legal aids and advices to the needy in the society.
- → Assist in providing education to the children belonging to financially unsound families irrespective of their castes.
- ♣ To organize effective sessions on "PREKSHA MEDITATION" in order to learn to handle problems tactfully and to overcome unending sessions.



He concluded by requesting members of TPF to serve Gurudev visiting on Chaumasa to their level best so that the upcoming Janamshatabdi of Acharya Mahapragyaji can be organized by TPF.
